I hereby waive and release Fish'n Fever Tournament Trail, it's officers, sponsors, all other contestants, tournament officials and launch facility from any and all claims from injury and/or damages occurred in connection with this tournament. If I am a boater in the tournament, I hereby acknowledge that I have current boater liability insurance in force during the date(s) of the tournament. I have also read and understand the rules for the event and I agree to abide by and adhere to these rules.

- A. **LIABILITY RELEASE:** In signing this agreement I hereby release Fish'n Fever Tournament Trail, its officers, directors, sponsors and launch facility from all damages, claims, demands, cost or expenses relating to injury of any person or any property which I may sustain or which I may cause by reason of participating in or in connection with this tournament. I understand that by participating in this tournament that I may cause or sustain injury including but not limited to: loss of life, loss of limb, paralysis, coma, loss of mental functions, loss of sight, loss of speech/smell, dehydration, exposure, hypothermia, frostbite, sunstroke and all other injuries that may be caused by boating or exposure to the elements. I further release Fish'n Fever Tournament Trail for all damages relating to adverse weather conditions while participating in this tournament. It is my responsibility to seek safety should adverse or unforeseen weather conditions should occur prior to or during the tournament.
- B. **COVENANT NOT TO SUE AND WAIVER OF SUBROGATION:** I further agree that I will never sue Fish'n Fever Tournament Trail or its officers for damages on account of injury, death or damage I suffer or cause whether known now or which I may develop in the future. In the event Fish'n Fever Tournament Trail is sued because of my actions, I expressly agree to indemnify Fish'n Fever Tournament Trail harmless from any liability whatsoever, including court costs and attorney's fees, arising from the respect of such actions. I understand that in waiving my rights to sue Fish'n Fever Tournament Trail I am also waiving the right of recovery from Fish'n Fever Tournament Trail of my insurance carrier for any claims that they may pay in my behalf.
